

## CONDITIONS UNDER WHICH PERMISSION IS GRANTED TO REPRODUCE WORKS OF ART FROM THE COLLECTION OF JOSLYN ART MUSEUM, OMAHA, NEBRASKA

- 1. Advance payment is required. Permission for reproduction is contingent upon receipt of advance payment and a signed copy of the agreement. Image files will not be released until any applicable fees and a signed agreement are received by Joslyn Art Museum (JAM, or the Museum).
- 2. All reproductions must be made from images supplied by JAM. Reproductions from materials not supplied by JAM is strictly prohibited.
- 3. Permission for reproduction is granted for usage in one publication, for one edition. Subsequent new editions will be considered upon request.
- 4. Permission is granted for production only. Permission to reproduce does not extend to marketing or other avenues (such as social media) without written permission.
- 5. Each work of art is to be reproduced in its entirety. Reproductions are not to be cropped or bled off the page, nor may overlays or other images be superimposed on the reproduction. If a detail of the image is to be used, special permission must be obtained, and label copy must specify that said image is a detail.
- 6. At its discretion, JAM may request proofs. Applicant will make all corrections deemed necessary by the Museum to ensure faithful reproduction. JAM reserves the right to revoke permission if, in its opinion, the applicant has not obtained acceptable standards of reproduction.
- 7. Electronic images (not including cover images) must be reduced to a low-res format before being published online.
- 8. The credit line (see agreement) must be shown in its entirety immediate proximity to the reproduction, or in the section of the publication or production (television/film/video) devoted to acknowledgements.
- 9. JAM does not supply images to companies or individuals operating a photo rental and/or sales service. Photographic materials may not be made by outside companies or photographers for commercial purposes without prior written consent of JAM.
- 10. Images may not be duplicated or transferred to a third-party under any circumstances.
- 11. Upon publication, the applicant must provide at least one (1) copy of the publication or appropriate tear sheet in which the reproduction appears. They should be sent to the attention of Rights and Reproductions, Joslyn Art Museum, 2200 Dodge Street, Omaha, NE 68102.
- 12. The Museum makes no representation that it is the owner of any copyright in the works of art in its collection. Certain works of art, as well as the photographs of those works of art, may be protected by copyright, trademark, or related interests not owned by the Museum. The Museum can grant the permission requested only to the extent of its ownership of the rights relating to the request. JAM's material and/or photographic fees do not include any fees due to the copyright owner or administrator (artist, representing gallery, estate, etc.).
  - a. It is the responsibility of the applicant to obtain permission from the copyright owner or administrator.
  - b. The applicant agrees to indemnify JAM and hold it harmless against all such claims, including copyright infringement claims, royalty or fee demands and/or actions, including the costs thereof, arising as a result of the applicant's reproduction of the work(s) of art in its collection.
